## Group claims

### Banking class actions

Advising a number of European banks on hundreds of recovery and liability proceedings in several jurisdictions arising from multi-billion non-performing Euro loan portfolios including the impact of European and national banking and insolvency legislation. Part of this work includes managing group claims in England and another EU Member State including parallel jurisdiction challenges in each jurisdiction and proceedings before the CJEU. Careful cooperation with the legal teams in each jurisdiction has ensured consistency of approach and evidence.

### Advice to institution

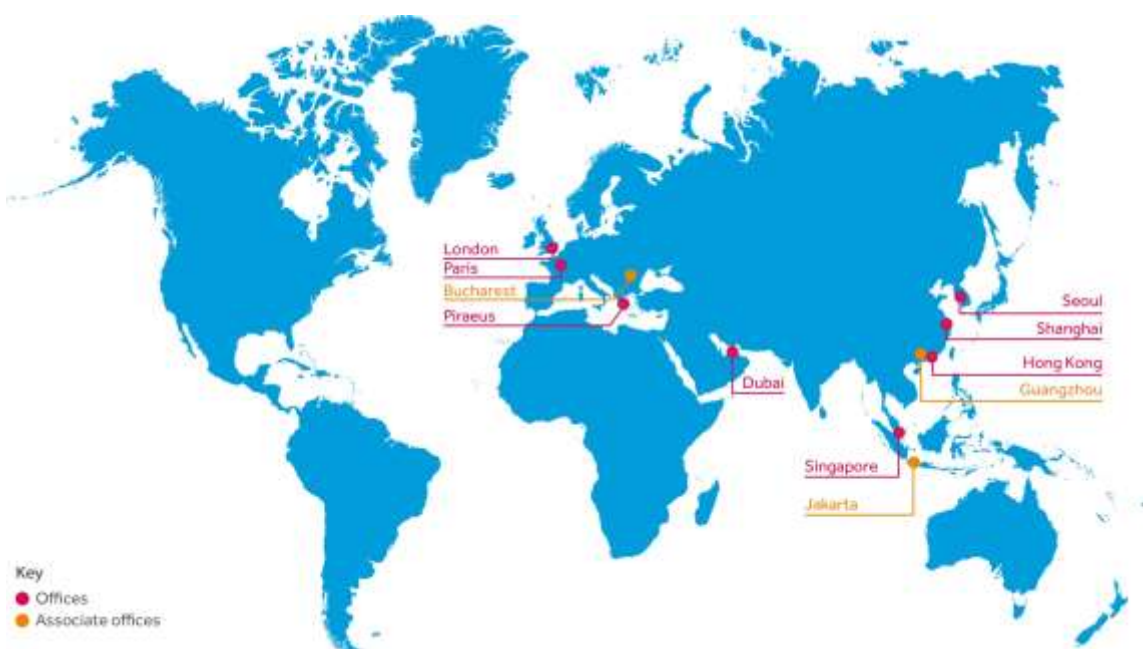
