## Our experience

### Transport

#### Road - UK infrastructure fund

We advised a major UK infrastructure fund on its bid to acquire two operational toll road PPP projects in Ireland – the N8 and the N7 bypass.

#### Rail - HS2

One of the largest rail construction and engineering projects in the world, we are supporting a consortium of major international construction companies on its bids for the main works civils packages that form part of the UK Government's High Speed Two project.

#### Airports - Lagos airport PPP
