Health and safety legislation and regulation applies across sectors, to almost all businesses. Where the relevant regulators – typically the Health and Safety Executive or Environmental Health Officers for Local Authorities – receive reports of accidents or risks, rapid intervention can follow, including the commencement of regulatory and/or criminal investigations and the use of statutory information gathering powers and Improvement and/or Prohibition Notices. Owing to the focus on risk, health and safety investigations can move rapidly, with information requests being made and interviews (including under caution) happening at an early stage and with limited notice.

Our market-leading regulatory litigation and investigations practice group has advised companies, across sectors, in several technical, legally, and factually complex investigations, disputes and enforcement actions.
